1. Minutes of 2024 AGM

There was one action item in these minutes related to disposal of trophies. Ian Birch reported that the remaining trophies were donated to a trophy shop for recycling.

2. 2024 Treasurer's Report (attached)

The attached report prepared by Larry Pommen and reviewed by Paul Standring was adopted. A loss of \$209.78 was due to expenses for the 50th club anniversary celebration, but the club was in a good financial position with a year-end balance of \$3325, above the minimum balance of \$2500 required in the event of a claim on our liability insurance with \$825 available for contingencies. It was agreed that there is no surplus for donations to young riders, and that additional fund-raising would be required for that purpose. On dissolution of the club, the assets of the club could be donated to young riders if that is the wish of the final membership.

3. 2024 Club Membership

Larry Pommen reported that to date the club has lost members compared to last year, which ended with 26 members (24 paid, 2 free). Current membership is 19 (17 paid, 2 free). One or two more 2024 members are expected to rejoin in 2025.

4. 2025 Financial Update

Larry Pommen reported that the essential club 2025 expenses will be at least \$408 versus the current revenue of \$340 from club memberships. It was agreed to increase the club fee for 2026 to \$25/person to compensate for the decline in membership revenue.

5. Club Dinner

Options were discussed for a pre-Christmas dinner at the Fireside Grill or a chefcatered dinner in the Travino Activity Centre, as well as a summer BBQ at the

Travino Activity Centre or the backyard of a club member. **Action: Larry Pommen**.
